The undersigned requests for reimbursement of the federal Recapture Tax paid following the sale or disposition of our home. Said home was purchased utilizing financing from the North Dakota Housing Finance Agency's Home Mortgage Finance Program (aka FirstHome Program).

As part of our request for reimbursement, we make the following statements, representations and warranties:

At the time we sold our home our NDHFA financed mortgage loan was still outstanding and had not been subsequently refinanced.

1. We have not previously requested NDHFA to reimburse us for any recapture tax with respect to the home described above. We will not submit another reimbursement request regarding this home for any reason, including, but not limited to, the payment of additional recapture tax because of any miscalculation.
2. We understand the NDHFA will reimburse us only for the amount of the recapture tax we report to the U.S. Treasury on Internal Revenue Service (IRS) Form 8828 (Recapture of Federal Mortgage Subsidy) and that NDHFA will not reimburse for any fees, interest, expenses or penalties incurred in connection with the recapture tax.
3. The information contained in our tax return for the calendar year in which a disposition of our home occurred was true and correct as of the date such return was filed with the IRS. Such information, together with the information included in this request for reimbursement of our recapture tax and in any other document or item requested by NDHFA, is or will be correct as of the date submitted to NDHFA.
4. We acknowledge that NDHFA's reimbursement of our recapture tax may constitute income to us for federal and/or state income taxes purposes, and that we may have to pay taxes on this additional income. We further acknowledge that NDHFA will not provide us with additional funds to pay such taxes. If we have questions regarding the treatment of the reimbursement for tax purposes, we will check with our tax advisor or the IRS.

We have attached to this request for reimbursement of our Recapture Tax the following:

We understand that NDHFA may need additional information/documentation to approve our request for reimbursement, and we will provide such documentation promptly upon request.
