1. PARTICIPATING LENDER TRAININGS + HOME TALK WEBCAST

Participating Lender Training helps mortgage lenders understand the specific homeownership programs NDHFA offers so their buyers can successfully utilize our programs. Offered in-person and virtual in the spring and fall for any lender needing additional training, we anticipate another year of high attendance. NDHFA also hosts Home Talk, a monthly webcast highlighting a range of homeownership topics, and consistently attended by 80+ viewers.

2. PROPERTY MANAGEMENT COMPLIANCE TRAINING

NDHFA's 2026 Property Management Training is geared towards property owners and managers around the state. They attend to learn key compliance topics for the various multi-family programs NDHFA administers. To be held at the Event Center in Bismarck April 14 – 16, 2026, this two-and-a-half day training will help attendees learn compliance and to better follow federal rules and regulations to continue to provide compliant rental housing in North Dakota.

3. COMMUNITY HOUSING NEEDS FORUMS

New for 2026, NDHFA plans to host at least three sessions focused on gathering community members, leaders, and elected officials together to discuss housing needs in North Dakota. Planned for Dickinson, Bismarck, and Fargo, these October forums will be an opportunity for voices to be heard and solutions to be discussed.
